The title, author, subject, and keywords may have been set by the person who created the document in the source application, such as Word or InDesign, or by the person who created the PDF. You can search for these description items to find particular documents.

Open the PDF document in Adobe Acrobat Pro: (OR GOOGLE CHROME EXTENSION) (1) Select File > Properties. (2) Select the Description tab to view the metadata in the document, including the document information dictionary. (3) Modify the Title field to add or change the document's Title entry.

Choose Set PDF Metadata (under the PDFs library) Save; when you drop your PDF on the file, it will change the title for you. More Steps, More Flexibility. The downside to that method is that while really simple, you can't programmatically change the Title (for whatever reason, you can't use variables in Set PDF Metadata). It's great for batches if you wanted to change the Author or Keywords for a bunch of files.
